Dear Mayor Barnett,

The Franklin Lions Club respectfully requests the use of the city parking lot at the northeast corner of Monroe and Water Street in downtown Franklin for our two annual fish fries. The Earl Wilson Memorial Fish Fry will be held on May 26 and 27, 2017 and our fall fundraiser will be held on September 29 and 30, 2017 as a part of the Franklin Heritage Festival. Our serving hours will be 11:00 a.m. – 7:00 p.m. each day. We request the use of the lot from **Thursday through Monday, May 25 – 29, 2017** and again from **September 28 – October 2, 2017**, respectively. We use Thursdays, prior to the event, to set up the tent, Sundays after the event to clean up and Mondays for the tent vendor to take down the tent. As in the past, we would ask that “no parking” signs be posted on the lot at the close of business on the preceding Wednesdays to make sure the lot is available on Thursday.

All of the proceeds from these events go to fund charitable contributions of the Franklin Lions Club which include but are not limited to the purchase of exams and eyeglasses for area school children, college scholarships for graduating Franklin Community High School students, scholarships to the Indiana Lions Law Camp, support of Camp Woodsmoke (a wilderness camp for disabled children), and many other community betterment programs. We also support Indiana Lions Cancer Control Fund, Indiana Lions Eye and Tissue Bank, Indiana Lions Speech and Hearing, Indiana Leader Dogs for the Blind, Indiana Lions Foundation and Lions Clubs International Foundation, an organization that provides immediate disaster relief worldwide.

Please put this request on the agenda for the Franklin Board of Works at the next available meeting. The Lions Club’s annual fish fries are long running community events that, in addition to providing funds for worthwhile charities, provide part of the fun and fabric of life in Franklin. We sincerely appreciate the cooperation and assistance of the City in these events and look forward to a favorable decision of the Board of Works.
