a. Franklin Little League – Request to place memorial in Scott Park

Mr. Alsop made an appeal to the Park Board on behalf of the Franklin Little League. They are asking permission to place a memorial at Scott Park for Caleb Buck, a year Little Leaguer who passed away. Caleb had been involved with Little League program for approximately 8 years and had been very inspirational to youth and adults alike. The Little League organization was asking for space to put a monument similar to the one honoring Franklin resident Danny Dewitt. They agreed to purchase the monument, provide annual upkeep and do repairs in case of vandalism. A motion was made by Michael Auger and seconded by Debbie Gill to approve a memorial for Caleb Buck to be placed at Scott Park subject to the approval of Director Chip Orner. The Board unanimously approved.
