## ORDINANCE NUMBER 2018-05 OF THE CITY OF FRANKLIN, INDIANA

# AN ORDINANCE APPROVING VACATING DRAINAGE & UTILITY EASEMENTS WITHIN THE CITY OF FRANKLIN, INDIANA

(To be known as Heritage Road/Bartram Parkway D&UE Vacation)

WHEREAS, Sunbeam FTP, LLC has filed before the Common Council of the City of Franklin a petition requesting that said drainage & utility easements as described herein be vacated for the reason that said easements are not at this time used for any public purpose and are not foreseeably needed by the City of Franklin for any public purpose; and

WHEREAS, descriptions of the subject drainage & utility easements are attached hereto, incorporated herein and marked as Exhibit "A" and are schematically shown on the attached Exhibit "B";

**WHEREAS,** the notices and advertisements required by IC 36-7-3-12 have been given, and a public hearing was held upon said petition on the  $\frac{\partial^{2}}{\partial x^{2}}$  day of  $\frac{\partial^{2}}{\partial x^{2}}$ , 2018.

# NOW, THEREFORE, THE COMMON COUNCIL OF THE CITY OF FRANKLIN, INDIANA, ORDAINS THAT:

- 1) The drainage & utility easements described above are hereby, pursuant to IC 36-7-3-16, declared vacated;
- 2) Utility easements shall be provided for any existing utilities that lie within the vacated easement. The utility easements shall be recorded and may be recorded as part of a plat;
- 3) A copy of this Ordinance shall be transmitted to the Recorder of Johnson County, Indiana;
- 4) This Ordinance shall become effective at the time of recording;

5) City Staff is authorized to execute all deeds necessary in accomplishment of the herein above.
