City of Franklin Common Council Regular Meeting Minutes May 20, 2019

The regular meeting of the Common Council of the City of Franklin, Indiana was called to order at 6:00 p.m. at City Hall, 70 E. Monroe Street, with Mayor Steve Barnett presiding. Council members Joseph Abban, Kenneth Austin, Daniel Blankenship, Andrew Eggers, Danny Richards and Richard Wertz answered roll call. Clerk-Treasurer Jayne Rhoades, Records Clerk Kathy Cragen, City Attorney Lynnette Gray were also present. Council member Bob Heuchan was absent.

Councilor Wertz offered an invocation. Mayor Barnett opened the meeting and asked the Clerk-Treasurer to call the roll. Mayor Barnett led the recitation of the Pledge of Allegiance.

The following timeline was presented: 3/19/19 Redevelopment Commission adopts declaratory resolution approving amendment of economic development plan and boundaries of economic development area; 4/16/19 Plan Commission adopts resolution approving amendment of economic development plan and boundaries of economic development area; 5/6/19 Common Council adopts resolution approving amendment of economic development plan; 06/03/19 Common Council adopts resolution approving Lease and pledging LIT revenues; 6/8/19 Publish Notice of Public Hearing of Redevelopment Commission on amendment of economic development plan (deliver notice to planning bodies); 6/8/19 Publish Notice of Public Hearing of Redevelopment Commission on Lease; 6/18/19 Redevelopment Authority meets and adopts Resolution approving from and execution of Lease; adopts Resolution authorizing issuance of bonds, approving forms of financing documents; 6/18/19 Redevelopment Commission holds Public Hearing on amendment of economic development plan and adopts confirming Resolution (makes filings with Auditor and DLGF); 6/18/19 Redevelopment Commission holds public hearing on Lease and adopts resolution finding lease rentals are affair and reasonable and approves execution of Lease; 6/18/19 Redevelopment Commission and Redevelopment Authority execute Lease; 6/21/19 Publish Notice of Execution of Lease; 6/24/19 Submit materials to rating agency; 7/15/19 Receive rating; 7/22/19 30-day objection period ends (obtain certificate from Auditor's office); 7/29/19 Price bonds and execute bond purchase agreement; submit notice of execution of BPA to newspaper for publication; Week of 8/12/19 Closing on bonds. A discussion was held. Ms. Gray stated that RDC Attorney Schafstall has asked to have this resolution tabled until the June 3rd meeting. Councilor Eggers made a motion to table, seconded by Council President Austin. A voice vote was taken with all members stating aye. The motion carried, and the resolution was tabled.

Council President Austin made a motion to read all new business by title only, seconded by Councilor Wertz. A voice vote was taken with all members stating aye. The motion carried.

Request Permission to Apply for a Johnson County Community Foundation Grant - Police Chief Kirby Cochran came forward to ask permission to apply for the Johnson County Community Grant which would be no more than \$15,000. Chief Cochran stated these funds would be used for their drone program they have just started. A discussion was held. Council President Austin made a motion to approve applying for this grant, seconded by Councilor Richards. A voice vote was taken with all members stating aye. The motion carried.
