**A RESOLUTION AUTHORIZING SINGLE SOURCE PURCHASE AND PERMITTING
PURCHASING AGENT TO PURCHASE COMPATIBLE EQUIPMENT,
ACCESSORIES AND REPLACEMENT PARTS**

WHEREAS, the City of Franklin, by and through its Board of Public Works, (hereinafter referred to as "City") is a government organization providing services to the citizens of Franklin, Indiana; and

WHEREAS, the Board of Public Works is the purchasing agent for purposes of acquiring personal property and supplies in furtherance of providing services to the City of Franklin residents; and

WHEREAS, the City provides sewer and stormwater services to its citizens through operation of its City sewer utility; and

WHEREAS, the City sewer utility is in need of replacing certain lift station pumps as well as FLYGT equipment for the Young's Creek lift station; and

WHEREAS, the replacement pumps necessary to operate the City of Franklin lift station are unique and only available from a single source; and

WHEREAS, the purchasing agent has received a quote for the purchase of these unique items which are compatible with the equipment currently in use at the Young's Creek lift station and also are provided by only one source to meet the City of Franklin's sewer utilities reasonable requirements as set forth in I.C. 5-22-10-8; and

WHEREAS, a copy of that quote for the purchase of the compatible equipment is attached hereto as Exhibit "A"; and

WHEREAS, the Board of Public Works does hereby determine in writing pursuant to I.C. 5-22-10-13 that there is only one (1) source for the supply and the purchasing agent determines this is the reasonable source for the supply; and

WHEREAS, further, the City determines that pursuant to I.C. 5-22-10-8 a special purchase is appropriate for the reason that the proposed equipment to be purchased is compatible with the existing equipment, accessories and parts needing replaced and that is a substantial consideration in the purchase.

BE IT THEREFORE RESOLVED the City of Franklin, by and through its Board of Public Works and Safety, as its authorized purchasing agent, does hereby adopt the above aforementioned as findings of fact; and

BE IT FURTHER RESOLVED the City of Franklin, by and through its Board of Public Works and Safety does hereby determine in writing there is only one source for the supply of the sewer pumps used in the City's reasonable requirements and that said parts in the proposed purchase are compatible with the equipment, accessories and parts to be replaced for the existing Young's Creek lift station.


BE IT FURTHER RESOLVED the authorized representative of the City of Franklin sewer services, is permitted to purchase the necessary pumps from a single supply source.


