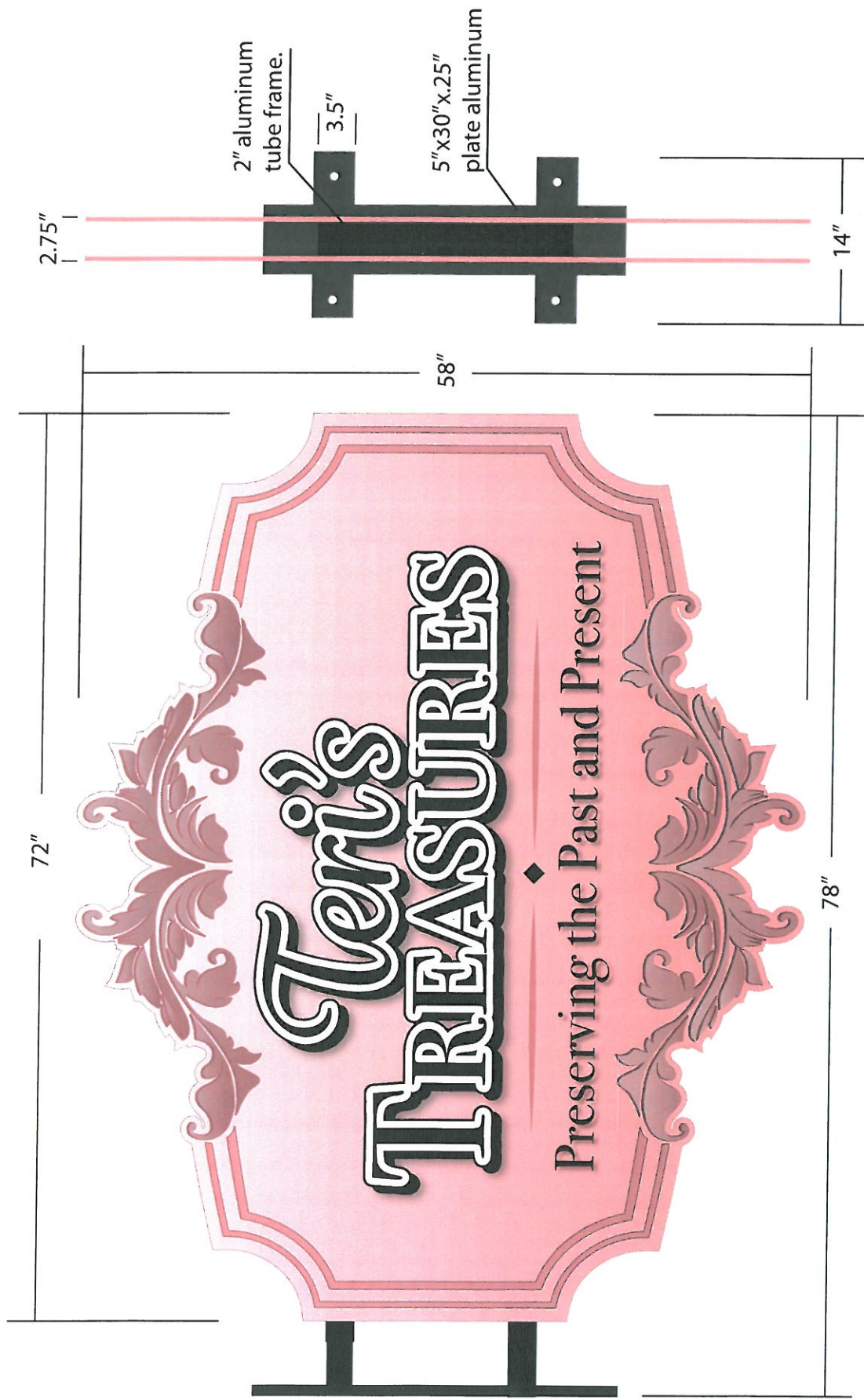

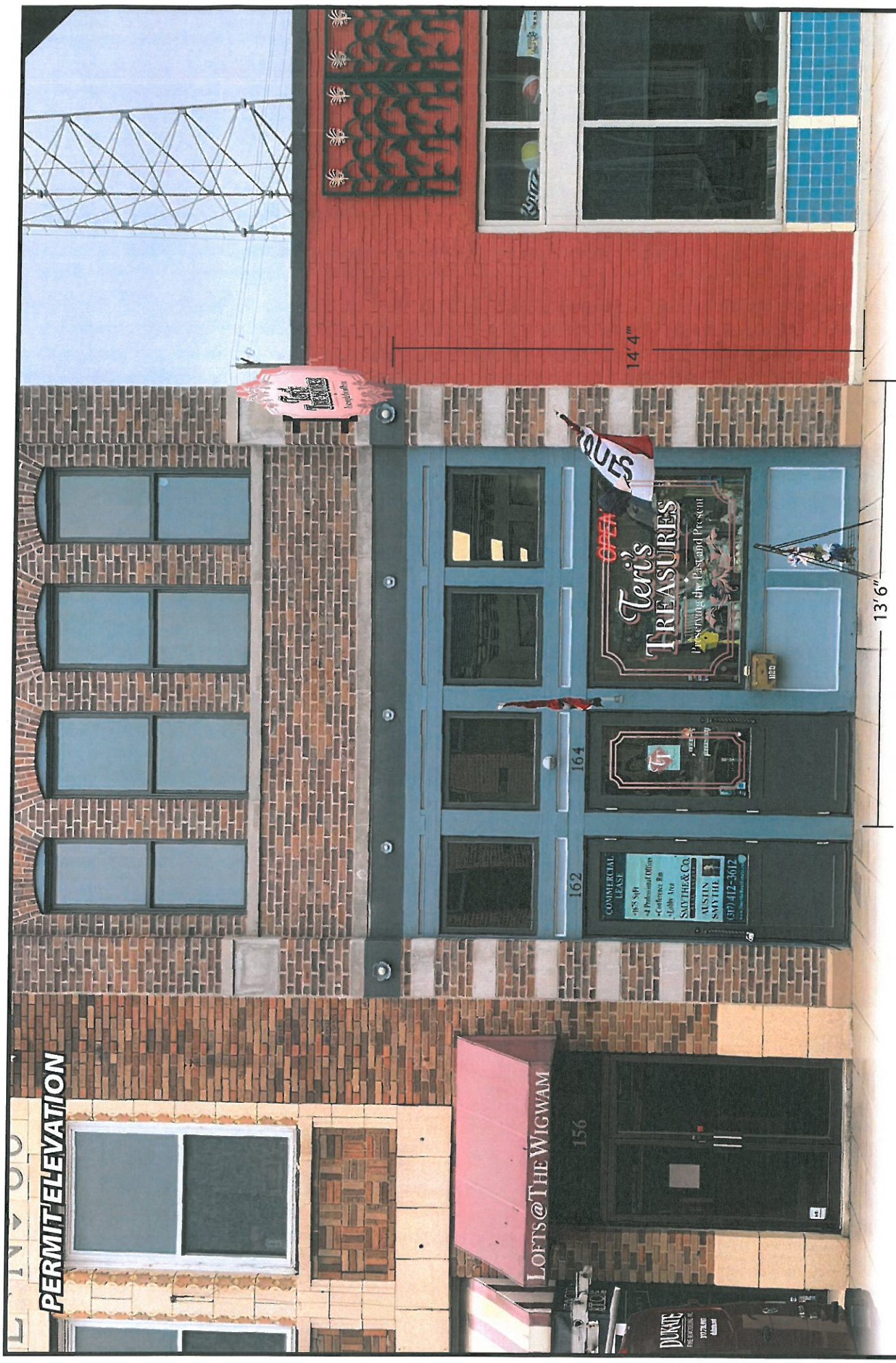

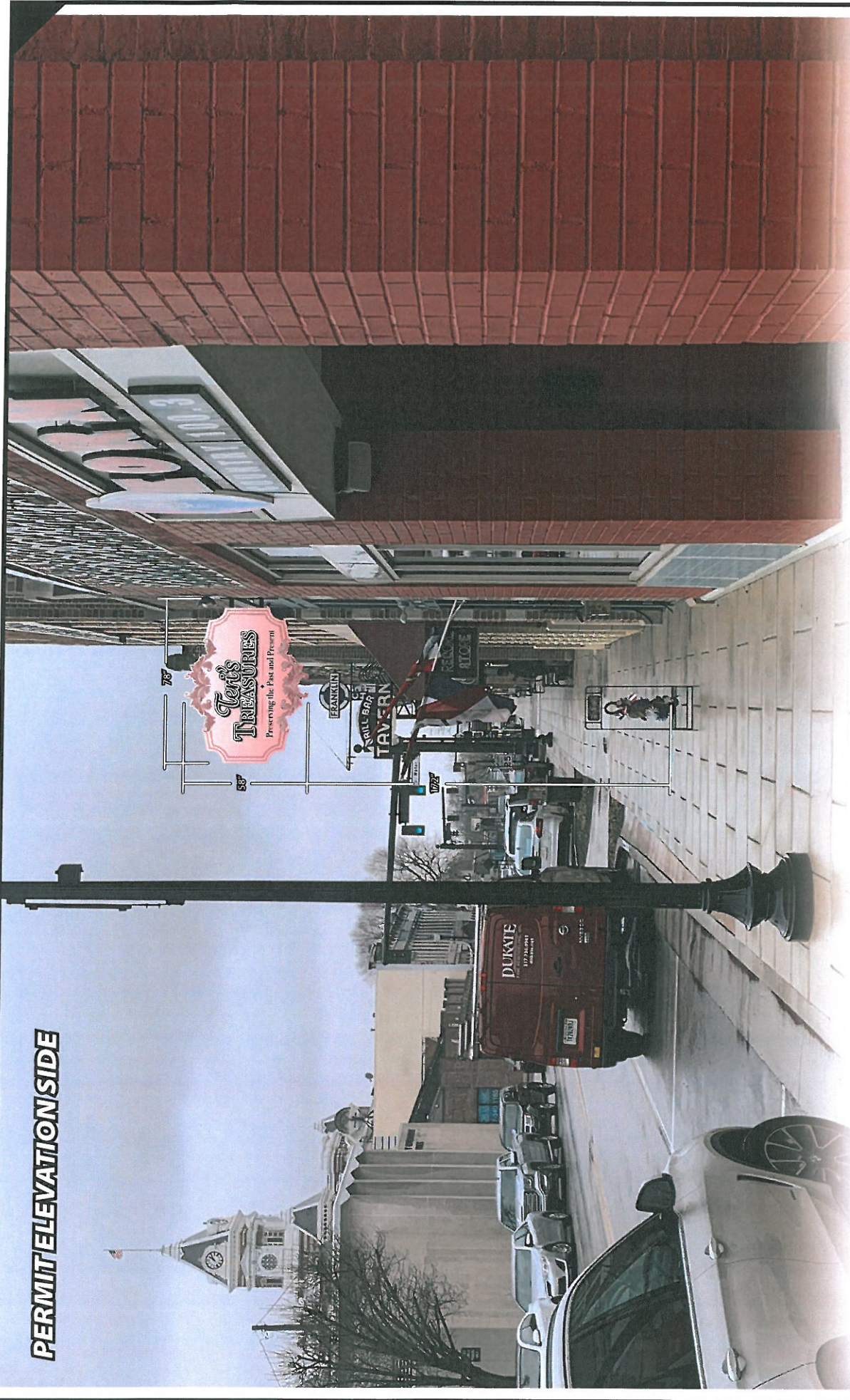


Non-illuminated 72"x58" double faced projecting wall sign.
