## BUDGETARY ORDINANCE No.: 20-13 AN ADDITIONAL APPROPRIATION ORDINANCE

**WHEREAS**, it has been determined that it is now necessary to appropriate grant money received from INDOT in the Local Road and Bridge Matching Grant Fund for the 2020 Community Crossings Grant in the amount of \$321,200.30.
