## RESOLUTION OF THE FRANKLIN REDEVELOPMENT COMMISSION AUTHORIZING EXPENDITURE OF TAX INCREMENT REVENUE BOND-SERIES 2015 FUNDS

## Appropriating \$200,026.66 of 2015 Bond Funds for Improvements related to the Shell Building Project

**WHEREAS**, the Franklin Redevelopment Commission (the "Commission") serves as governing body of the Franklin Redevelopment District (the "District"), pursuant to Indiana Code 36-7-14 et seq., as amended (the "Act");

WHEREAS, the Commission has previously established the Franklin / I-65 Integrated Economic Development Area (the "Area"), designated allocation areas within the area (the "Allocation Area") for purposes of capturing tax increment ("TIF Revenues"), created an allocation fund or funds (the "Allocation Fund") for the Area into which the TIF Revenues are deposited, approved the Franklin / I-65 Economic Development Plan (the "Plan"), and borrowed monies pursuant to the Tax Increment Revenue Bond - Series 2015 to fund development consistent with the Plan; and

WHEREAS, the Commission now desires to authorize the use of and allocate unobligated funds from the Tax Increment Revenue Bond - Series 2015 to fund expenses related to the Shell Building project ("Project"), plus the administrative expenses for same, in an amount not to exceed Two Hundred Thousand Twenty-Six Dollars and 66/100 (\$200,026.66), specifically including for the purchase and acquisition of real property from F. Maurice Linville and Helen Linville for the site to be used for the construction of the shell building.

**NOW, THEREFORE, BE IT RESOLVED** by the City of Franklin Redevelopment Commission, that:

- 1. The Commission hereby authorizes the expenditure of and allocates unobligated funds on deposit from the Tax Increment Revenue Bond Series 2015 in an amount not to exceed Two Hundred Thousand Twenty-Six Dollars and 66/100 (\$200,026.66), for the Project, payable directly to F. Maurice Linville and Helen Linville. The Commission hereby finds and determines that the Project is located in the Area and will further the objectives of the Plan.
- 2. The Clerk-Treasurer of the City of Franklin, Indiana is hereby authorized to disburse the monies from the Tax Increment Revenue Bond Series 2015 for the Project. The Mayor and Clerk-Treasurer of the City, the officers of the Commission and the Director of the Department of Community Development, are hereby authorized and directed to take such further actions and execute such documents, as they deem necessary or advisable to effectuate the authorizations set forth in this Resolution.
  - 3. This Resolution shall take effect immediately upon adoption by the Commission.
