AN ORDINANCE APPROVING VACATING RIGHT-OF-WAY WITHIN THE CITY OF FRANKLIN, INDIANA BETWEEN LOTS 73, 74, 75 & 76 IN ORIGINAL PLAT OF FRANKLIN (To be known as OP Franklin Lots 73-76 Alley Vacation)

WHEREAS, City of Franklin has filed before the Common Council of the City of Franklin a petition requesting that said public right-of-way as described herein be vacated for the reason that said public ways are not at this time used for any public purpose and are not foreseeably needed by the City of Franklin for any public purpose; and

WHEREAS, subject public way is an alley 12 feet in width and runs north and south described as follows and as shown on Exhibit "B":

The alley lying between Lots 73, 74, 75, & 76 in the Original Plat of Franklin, the City of Franklin, Indiana, as per plat thereof recorded in Plat Book 1, Page 1, in the Office of the Recorder of Johnson County, Indiana, more particularly described as follows:

Beginning at a point, said point being the Southwest corner of said Lot 74; thence westerly, 12 feet to the Southeast corner of said Lot 76; thence Northerly, along the East line of said Lots 76 and 75, 144 feet to the Northeast corner of said Lot 75; thence easterly, 12 feet to the Northwest corner of said Lot 73; thence Southerly, along the West line of said Lots 73 and 74, 144 feet to the Southwest corner of said Lot 74, being the point of beginning of the herein described tract.

WHEREAS, the notices and advertisements required by IC 36-7-3-12 have been given, and a public hearing was held upon said petition on the 300 day of MAY, 2021.

NOW, THEREFORE, THE COMMON COUNCIL OF THE CITY OF FRANKLIN, INDIANA, ORDAINS THAT:

- 1) The public way described above is hereby, pursuant to IC 36-7-3-12, declared vacated;
- 2) Any utility easements shall remain for the length and width of the vacated right-of-way;
- 3) A copy of this Ordinance shall be transmitted to the Recorder of Johnson County, Indiana;
- 4) This Ordinance shall become effective at the time of recording;
- 5) City Staff is authorized to execute all deeds necessary in accomplishment of the herein above.
