## BUDGETARY ORDINANCE No.: 21-13 AN ADDITIONAL APPROPRIATION ORDINANCE

**WHEREAS**, it has been determined that it is now necessary to appropriate money in the Local Road and Bridge Matching Grant Fund for the 2020 Community Crossings Grant Part 2 in the amount of \$ 221,594.00.


