

# CITY OF FRANKLIN, INDIANA

## BUDGETARY ORDINANCE No.: 21-14 AN APPROPRIATION REDUCTION ORDINANCE

**WHEREAS**, it has been determined that it is now necessary to reduce the appropriation in the MVH Fund-Capital in the amount of \$ 500,000.00 and LRS Fund-Capital in the amount of \$44,554.00 due to the transfer of MVH & LRS funds to the Local Road & Bridge Matching Grant Fund.

**NOW THEREFORE**, be it ordained by the Common Council of City of Franklin, Indiana that for the expenses of the taxing unit the following appropriation reduction is hereby appropriated out of the funds named and for the purposes specified, subject to the laws governing the same:






