Ordinance / Resolution Number: 21-20

Be it ordained/resolved by the **City of Franklin** that for the expenses of **FRANKLIN CIVIL CITY** for the year ending December 31, **2022** the sums herein specified are hereby appropriated and ordered set apart out of the several funds herein named and for the purposes herein specified, subject to the laws governing the same. Regular Meeting Minutes
October 4, 2021

The regular meeting of the Common Council of the City of Franklin, Indiana was called to order at 6:00 p.m. at City Hall, 70 E. Monroe Street, with Mayor Steve Barnett presiding. Council members Bob Heuchan, Melissa Jones, Anne McGuinness, Chris Rynerson and Shawn Taylor answered roll call. Clerk-Treasurer Jayne Rhoades, and City Attorney Lynnette Gray were also present. Councilor Kenneth Austin & Councilor Daniel Blankenship called in remotely.

Mayor Barnett opened the meeting and asked the Clerk-Treasurer to call the roll.

Bryan Ries offered an invocation, & led the recitation of the Pledge of Allegiance.

Adoption of 2022 Budget Common Council Budgetary Ordinance 21-20- Mayor Barnett gave a review of the 2022 Budget & stated it is ready for adoption. A discussion was held. Councilor Heuchan made a motion to approve, seconded by Councilor McGuinness.
