

**City of Franklin Common Council
Regular Meeting Minutes
June 6, 2022**

The regular meeting of the Common Council of the City of Franklin, Indiana was called to order at 6:00 p.m. at City Hall, 70 E. Monroe Street, with Mayor Steve Barnett presiding. Council members Kenneth Austin, Bob Heuchan, Melissa Jones, Anne McGuinness, Irene Nalley, Josh Prine and Shawn Taylor answered roll call. Clerk-Treasurer Jayne Rhoades, and City Attorney Lynnette Gray were also present.

Mayor Barnett opened the meeting and asked the Clerk-Treasurer to call the roll.

Bryan Ries offered an invocation, & led the recitation of the Pledge of Allegiance.

Announcements, Presentations & Public Comments

Award Presentation – Mayor Barnett presented the Marty & Carolyn Williams Volunteer of the year award to Gary Kiesel & thanked him for all of this volunteer work around the City.

Consent Agenda

Mayor Barnett presented the consent agenda for approval.

Council President Austin made a motion to approve the consent agenda as presented, seconded by Councilor Taylor. A voice vote was taken with all members stating aye. The motion carried.

Old Business

Public Hearing

Common Council Budgetary Ordinance No.: 22-11 An Additional Appropriation ARPA Grant Fund Capital 2401 001 400 in the amount of \$303,392.50 - Clerk Treasurer Jayne Rhoades stated this was presented at the previous meeting. Mayor Barnett opened the floor for public hearing, no one asked to speak. Councilor Taylor made a motion to approve, seconded by Councilor Prine. A voice vote was taken with all members stating aye. The motion carried.

New Business

Council President Austin made a motion to read all new business by title only, seconded by Councilor Taylor. A voice vote was taken with all members stating aye. The motion carried.

Common Council Ordinance No.: 22-03 Rezoning to be known as Eagles Landing PUD (Introduction) - Senior Planner Joanna Tennell gave an overview of this ordinance, & stated it is for introduction only tonight, & will be brought back June 20th for Public Hearing.

Common Council Resolution No.: 22-11 Authorizing Cash Change Accounts for the Park & Recreation Department (Repealing & Replacing Resolution 22-03 - Parks Superintendent Chip Orner stated this resolution is to increase the amount of cash change in the Amphitheater account from \$1000.00 to \$3,000.00. A discussion was held. Councilor Jones made a motion to approve, seconded by Councilor Taylor. A voice vote was taken with all members stating aye. The motion carried.

Common Council Budgetary Ordinance No.: 22-12 An Additional Appropriation Park Impact Fund Capital 4443 001 400 in the amount of \$49,000.00 - Parks Superintendent Chip Orner stated this ordinance is to appropriate money from the Park Impact Fund for the Amphitheater Project. Mr. Orner stated this is for introduction only tonight.

Other Business

There was no other business presented.

Council Comments

Council President Austin stated the Parks Department was doing a great job with the Amphitheater.

Councilor Jones thanked the Parks Department for a great job.

Councilor Prine thanked the Parks Department.

City Attorney Gray spoke about redistricting Council areas by the end of 2022.
