CITY OF FRANKLIN RESOLUTION NO.:2022-12 A RESOLUTION FIXING THE MILEAGE REIMBURSEMENT RATE FOR OFFICERS AND EMPLOYEES OF THE CITY OF FRANKLIN

WHEREAS, The City of Franklin hereinafter referred to as the "City", has in the past reimbursed transportation expenses of City officers and employees while using their private vehicles, and

WHEREAS, The City of Franklin Common Council authorized mileage reimbursement rates in 2008 for personal vehicle usage in the conduct of official City business at .50 cents per mile, and

WHEREAS, The Indiana State Board of Accounts allows such reimbursement if a reasonable rate per mile is fixed by ordinance or resolution of the legislative body, and

WHEREAS, The cost of gasoline, and other motor fuels has risen to an average of \$5.00 per gallon, and

WHEREAS, The Federal Government raised the employee Federal reimbursement rate to 62.5 cents as of JULY 1st, 2022 and

WHEREAS, It is considered necessary and desirable for the City to adopt a formal policy regarding rates of reimbursement for travel expenses for City officers and employees while using their private vehicles in the performance of their duties,

NOW THEREFORE, BE IT RESOLVED that the Common Council of the City of Franklin adopts as follows:

- 1) That it is deemed necessary and advisable that a formal policy be enacted for the reimbursement of actual and necessary travel expenses incurred by City officers and employees required to use privately owned vehicles in the performance of their duties.
- 2) That from and after passage of this resolution the City will reimburse City officers and employees for the use of their private passenger vehicles, at the rate of 62.5 cents per mile.
