ORDINANCE NO. 23-03

A BUDGETARY ORDINANCE FOR APPROPRIATION OF ECONOMIC DEVELOPMENT INCOME TAX (EDIT)

WHEREAS, the City of Franklin (the "City") has received Economic Development Income Tax (EDIT) money from Johnson County; and

WHEREAS, the City of Franklin Common Council as the fiscal body of the "City" did adopt a Capital Improvement Plan pursuant to I.C. § 6-3.6-6-9.5 specifying the uses of revenue to be allocated for economic development purposes; and

WHEREAS, the City of Franklin (the "City") desires to use revenues generated from the Economic Development Income Tax ("EDIT") for economic development purposes, as well as any other permitted use; and

WHEREAS, on December 19th, 2022 the City of Franklin Common Council did approve and adopt a Capital Improvement Plan of the City of Franklin, Indiana which plan became effective January 1st, 2023 and shall continue until December 31st, 2024.

NOW, THEREFORE, BE IT RESOLVED AND ORDAINED, by the Common Council of the City of Franklin, Indiana, that for the expenses of the taxing unit as permitted by the adopted Economic Development Income Tax Capital Improvement Plan the following additional sums of money are hereby appropriated out of the funds named and for the purposes specified, subject to the laws governing the same:
