### **New Business**

Merge Marketing with Programming Committees – Dana Monson – Groundwork-level marketing has been excellently accomplished by the marketing committee under the leadership of Dave Windisch. Going forward, they will merge with the programming committee, working hand in hand to continue marketing of the value of art to Franklin and the art events and activities as scheduled throughout the year. Mr. Hendrickson asked who will be chair. Ms. Monson said they could work it out as a committee.

Franklin Jeweler's Proposed Mural Design – Josh Shanafelt, owner of Franklin Jewelers, presented. It has been a longtime dream of theirs to have public art on this wall of their building. Through last year's Canvas Clash, they began talks with Greg Potter and Lee, and arrived at the art presented at this meeting. Commission members spoke of their support for the art. Mr. Shanafelt added the strong community enthusiasm they have received for the art. Ms. Monson explained that this was already presented to the Board of Zoning Appeals who approved the size and scope of the mural. An email vote took place with the PAAC members to allow the mural to move forward primarily due to weather so it could be worked on during the First Friday event in Franklin. Greg Potter stated that they would not deviate from the art images presented. They hope to finish on Saturday during Porchtober. He also stated that as the artist he will abstain from the vote. Nick Crisafulli and Mr. Causey expressed appreciation for Franklin Jewelers' participation in the community. Mr. Windisch expressed his support for the mural and asked for clarification about a retailer not being permitted to have art rendering on the exterior of their building of the product they sell. Alex Getchell clarified that the BZA does not see or know ahead of time what the art or content will be. This precludes any perceived bias for or against the proposed content. The BZA's consideration is only for location and size. Mr. Kosky concurred with Mr. Windisch's original understanding, stating a specific incident with another municipality. Ms. Monson explained that the situation did occur and was found to be illegal to not approve based on content. Mr. Causey made a motion for approval. Mr. Windisch seconded. Passed, 8-0, with an abstention from Mr. Potter.
