RESOLUTION NO. 2025-08

A RESOLUTION DENYING WAIVER FOR NON-COMPLIANCE WITH TAX ABATEMENT COMPLIANCE REQUIREMENTS FOR Pure Development (Res. 2021-28)

WHEREAS, the Common Council of the City of Franklin, Indiana (the "Council") granted on August 2, 2021, through Resolution No. 2021-28, a 10-year tax abatement on real property with a 2% economic development fee for Peterson Property Group located at 2280 McClain Drive;

WHEREAS, Pure Development, the new owners of the facility, failed to file Form 322 RE ("Schedule of Dedication from Assessed Valuation for Real Property in Economic Revitalization Areas") in 2024 with the Auditor of Johnson County, Indiana; and

WHEREAS, pursuant to Indiana Code Section 6-1.1-12.1-11.3(a)(5), the Council finds that this non-compliance shall not be waived, and Pure Development shall not be granted the first year of their tax abatement for the first year of increased assessed value, which is 2024, pay 2025.

NOW THEREFORE, BE IT RESOLVED by the Common Council of the City of Franklin, Indiana, as follows:

- 1. Waiver of Non-Compliance: Pure Development's non-compliance with its tax abatement filing requirements of Form 322 shall not be waived for the 2024 pay 2025 taxes.
- 2. Nothing set forth herein is, or should be interpreted to be, a waiver of the requirement to timely file Forms 322 RE and the CF-1 yearly form for future years to comply in all respects with the requirements of the tax abatement granted through Resolution No. 2021-28.
- 3. Effective Date: This Resolution shall be in full force and effect from and after its passage by the Council and approval by the Mayor as required by law.
