## **RESOLUTION NO. 2011-07**

## RESOLUTION OF THE COMMON COUNCIL OF THE CITY OF FRANKLIN, INDIANA APPROVING THE CONSOLIDATION OF ECONOMIC DEVELOPMENT AREAS AND RELATED MATTERS

WHEREAS, the City of Franklin Redevelopment Commission (the "Commission"), as the governing body for the City of Franklin Redevelopment Department, pursuant to Indiana Code 36-7-14, as amended (the "Act"), by a resolution adopted on October 28, 1993, as confirmed by a resolution adopted on December 9, 1993 and as amended by a resolution adopted on August 24, 1994 (as amended, the "Best Buy Resolution"), designated an area known as the Franklin Business Park Economic Development Area (the "Best Buy Economic Development Area"), as an economic development area pursuant to Section 41 of the Act and designated within such area several allocation areas pursuant to Section 39 of the Act, and approving an economic development plan for the Best Buy Economic Development Area; and

WHEREAS, the Commission, by a resolution adopted on May 8, 2008, as confirmed by a resolution adopted on June 18, 2008 (the "Integrated Resolution") designated an area known as the Franklin Downtown/I-65 Integrated Economic Development Area (the "Integrated Economic Development Area"), as an economic development area pursuant to Section 41 of the Act and approved an economic development plan for the Integrated Economic Development Area (the "Integrated Economic Development Plan"); and

WHEREAS, on August 18, 2011, the Commission adopted a Resolution (the "Amending and Consolidating Resolution"), which (i) amended the Integrated Resolution and the Best Buy Resolution to include the area currently in the Best Buy Economic Development Area in the Integrated Economic Development Area, and (ii) amended the Integrated Economic Development Plan to reflect such change in boundaries to the Integrated Economic Development Area (the "Plan Amendments"); and

WHEREAS, the Franklin City Plan Commission, on September 20, 2011, approved and adopted Resolution No. PC 2011-11 (the "Plan Commission Order") determining that the Amending and Consolidating Resolution and the Plan Amendments conform to the plan of development for the City and approving the Amending and Consolidating Resolution and the Plan Amendments; and

WHEREAS, pursuant to Sections 16(b) and 41 of the Act, the Redevelopment Commission has submitted the Amending and Consolidating Resolution, the Plan Amendments, and the Plan Commission Order to this Common Council of the City of Franklin, Indiana (the "Council").

NOW, THEREFORE, BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY OF FRANKLIN, INDIANA, THAT:

1. Pursuant to Sections 16(b) and 41 of the Act, the Council hereby approves, in all respects, the Amending and Consolidating Resolution, the Plan Amendments, and the Plan Commission Order.
