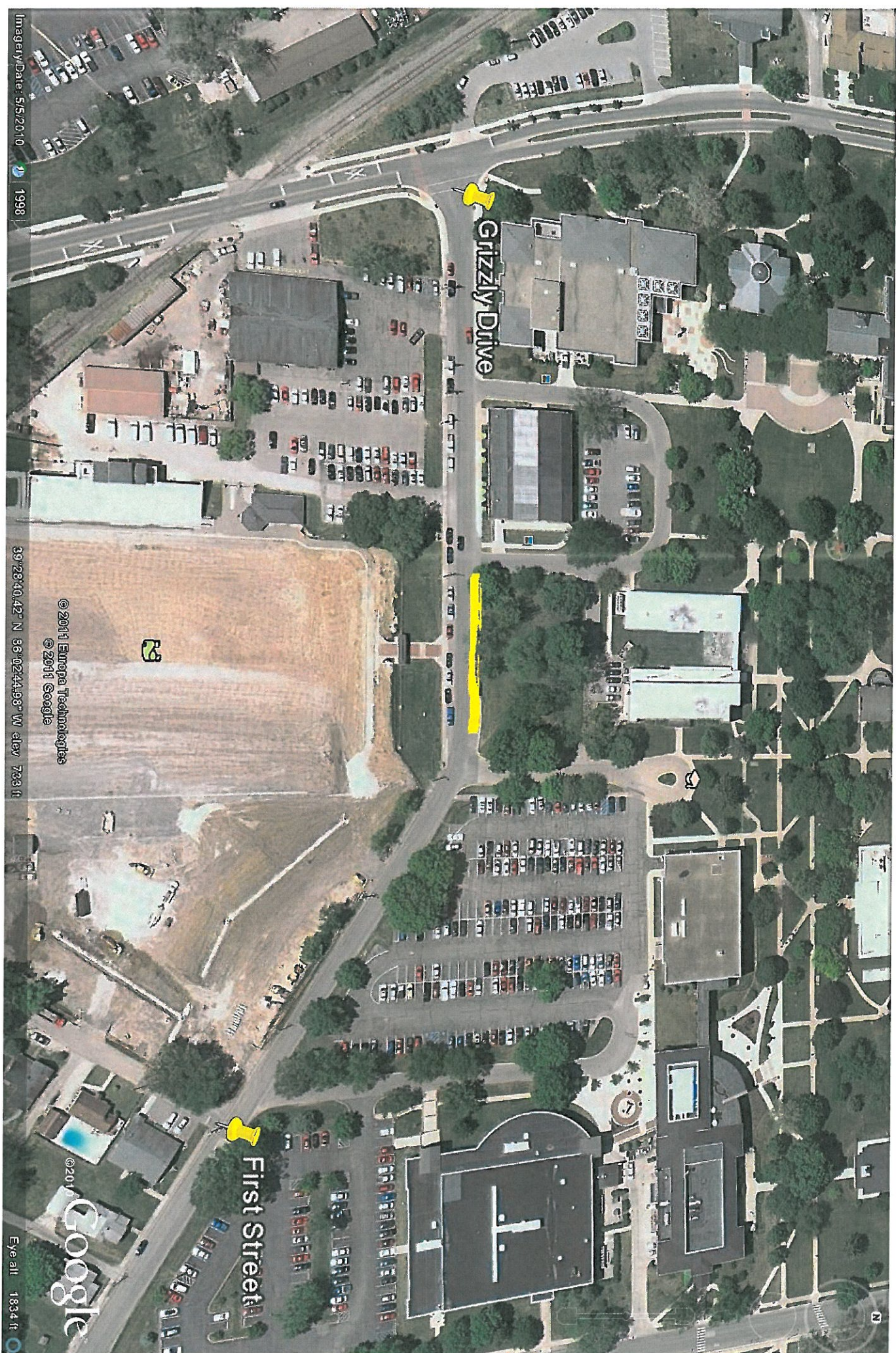
Re: Request for home football games 2012
