Park Board Meeting May 21, 2007



The Franklin Park Board met Monday, May 21, 2007 at 7:00 p.m. at the Franklin Cultural Arts and Recreation Center with President Pam Ault presiding.

Those present were Pam Ault, Margaret Beeson, Dr. William Province II, Ted Server, Suzanne Findley, Chip Orner, Attorney Andy Woods, and Pam Barnhizer-Briggs.

All claims were approved and signed.

A motion was made by Ted Server and seconded by Margaret Beeson to adopt the agenda. The board unanimously approved.

A motion was made by Ted Server and seconded by Dr. William Province to approve the minutes of the previous meeting. The board unanimously approved.

Reports:

Superintendent

- The Franklin Memorial Swimming Pool will be opening Sunday, May 27th. Two positions will need to be filled due to lack of re-certification. The pool is damaged on the bottom and needs to be professionally re-finished in 2008, prior to opening. Suzanne stated that she had added that maintenance need to the pool budget for 2008.
- Cicoa contract, for use of the Senior Center and food preparation, was presented for approval. The motion was made by Dr. Province and seconded by Margaret Beeson to approve the contract.
- E-mail received from a local minister to request reserving the Senior Center on a weekly basis for church services. The motion was made by Pam Ault and seconded by Ted Server to prohibit continual reservations for church services so that others have the opportunity to rent the facility. The board unanimously approved.

President of the Board:

Nothing to report.

Other Board Members:

Ted Server had a question about the Farmers Market being held downtown. Downtown Franklin will be sponsoring a Farmers Market on Wednesdays from 3:00 p.m. to 6:00 p.m. on East Court Street. We have been discussing the two markets and the use of both places.

Old Business:



- 1. Roof Report and Recommendation: Attorney Andy Woods reported that the inspection report from American Structurepoint Engineers has indeed indicated the damage on the Cultural Arts and Recreation Center roof was not due to hail damage, but was due to defective shingles. His recommendation was to accept the \$12,899.99 compensation offer. The motion was made by Ted Server and seconded by Dr. Province to accept the \$12,899.99 check and place it in the Park General Fund earmarked towards roofing when the time comes to do so, and that the present type of shingles not be used in the future. The board unanimously approved.
- 2. Boys and Girls Club Long Range Plan: A long range plan handout was given to the board for their review.

New Business:

- 1. 2008 Budget Approval: The motion was made by Dr. William Province and seconded by Margaret Beeson to approve the preliminary 2008 budget (excluding salaries) including an additional \$10,000.00 in Community Center extra help to cover additional custodial services needed at the Wonder Five Center. This will eliminate having to add a full time person in that area. The board unanimously approved. (See attached.)
- 2. Staff Safety and Training Awards: The motion was made by Dr. Province and seconded by Margaret Beeson to approve an awards program as part of the safety and training of the various department areas. The award will be 3-5 T-Shirts and/or sweatshirts for those going thru the training programs. The training must be validated on a training form and given to the Administrative Assistant for filing. The board unanimously approved.

The motion was made by Dr. Province and seconded by Margaret Beeson to adjourn the meeting with no further business to discuss. The board unanimously approved.

The next meeting is scheduled for Monday, June 18, 2007 at 7:00 p.m.

Dear Ms. Ault:

We have completed the evaluation of your roofing claim.

Based upon our evaluation of the claim, a determination has been made to provide a reimbursement for the shingles according to the terms and conditions contained in the published Limited Asphalt Shingle Warranty, which provides a prorated settlement based on the shingle value per square with credit for months remaining on the warranty.

Please keep in mind that there are many factors beyond the manufacturer's control which may account for the shingles not lasting the entire warranty period. For example, Hail storms, high winds, misapplication, etc. Despite these factors, CertainTeed is still extending a settlement based on the terms of the warranty. You may be entitled to additional consideration from your insurance carrier for some of the factors mentioned above.

CertainTeed understands that the reimbursement amount does not cover the total re-roofing costs, however, this limited warranty is based on material only and unfortunately does not include labor or tear-off costs etc.
