
Re: 400 S. Main Street

Following the Flood of 2008, the Sewer Billing office put a hold on all sewer bills for the properties included in the Buyout Project. As the properties were purchased by the City through the grant process, the outstanding sewer bills were paid by being deducted from the purchase price of the properties at the time of closing. These amounts were noted on the titlework and closing statement.

In reviewing their records, Sherry Phillips, Billing Manager for DPW, noticed that there was an outstanding sewer bill for the property located at 400 S. Main Street. This property was originally to be included in the Buyout Project but was then later removed from the list as the owners, Jonathan & Lisa Warner, offered to donate the property to the City.

Prior to closing on April 13, 2009, titlework was provided that did not include an outstanding amount for sewer usage. The attached invoice shows that \$25.66 was due for the period of October 1-31, 2008. The outstanding sewer bill should have been paid at the time of closing in which the City took title. This did not occur.

The City then held an auction and transferred the property to Jack Bradley. The outstanding sewer bill should have then been paid at the time that closing occurred and it was not. In order for the City to transfer the account to the current owner of record, the outstanding bill needs to be paid. Due to the chain of events outlined above, we are requesting that the Board of Works pay the outstanding sewer bill of \$25.66.
