WHEREAS, the Common Council of the City of Franklin, Indiana has considered the request of Ray's Trash Service to seek application of an Industrial Recovery Tax Credit from the Indiana Economic Development Commission;

WHEREAS, participation by a corporate entity in the Industrial Recovery Tax Credit program requires a joint application between a company and municipality;

WHEREAS, in order for a company to seek an Industrial Recovery Tax Credit, a local municipality must first pass a resolution granting approval of the executive of the municipality to submit a joint application;

WHEREAS, the Common Council of the City of Franklin, Indiana believes that participation in said program will promote economic development within the City of Franklin;

NOW, THEREFORE, THE COMMON COUNCIL OF THE CITY OF FRANKLIN, INDIANA, RESOLVES:

- 1) **Approval of Joint Application.** After legally required public notice, the Common Council of the City of Franklin, Indiana hereby takes action to approve the joint application of Ray's Trash Service and the City of Franklin to participate in the Indiana Economic Development Commissions programs for Industrial Recovery Tax Credit.
- 2) **Approving Resolution.** By the terms of this Resolution, the Mayor of the City of Franklin, Joseph E.
