The Franklin Park Board is requesting a change to the Common Council Resolution 07-06 regarding the use of merchant issued line of credit and/or store credit card accounts.

Since 2006 an increase in spending on the Sam's Club Direct account has occurred for several reasons.

- Kickapoo Kids Camp has increased from 60 to 125 campers.
- Park Concessions revenue has increased from \$961.06 to \$30,689.04
- Pool Concessions revenue has increased from \$26,942.99 to \$49,094.06
- Active Adult Center membership has increased from 100 to 245
- Franklin Swim Club membership has increased from 40 to 70

With the expansion of the Franklin Family Aquatic Center including the Zero Depth Pool and new Water Slide we are anticipating a significant increase in attendance.

Of course with the passage of time product costs are also significantly higher and are passed on to the consumers.
