# PRECIOUS METAL DEALER LICENSE APPLICATION PACKET

#### **Summary of Precious Metal Dealer Policy**

Any person who engages in business as a precious metal dealer as defined by Indiana Code 24-4-19 (effective January 1, 2014) in the City of Franklin must first obtain a license from the Franklin Police Department. All established requirements shall be met prior to a license being issued.

The City of Franklin has established a procedure by which the applicant is assisted with obtaining the necessary license. This process is outlined in the remainder of this document.

Precious Metal Dealer License Fee = \$50.00 (annual)

The Police Department is willing to assist the applicant; however, staff cannot provide legal advice. Compliance with the requirements of applicable laws and procedures remains the responsibility of the applicant. Should the applicant or interested parties have questions regarding legal matters, they are encouraged to seek independent legal advice.

#### Requirements

Requirements of operating as a licensed precious metal dealer are outlined below:

- Record Book shall be kept.
- Card Record to be kept at place of business.
- Record of pawned articles from previous business day must be reported on LeadsOnline by noon of each day.
- Photographic Recording Devices for use in recording each customer transaction.
- Precious metals shall be photographed in the condition they are received.
- Precious metals shall be retained in the condition they are received for a minimum of 10 calendar days after purchase date by dealer.
